

February 2025	Board Reviews Public Comment, Selects Management Options and Considers Final Approval of Addendum VII
TBD	Provisions of Addendum VII are Implemented


Background


- Proposed rule published by NOAA Fisheries in August 2024
 - Area-based gear requirements include both federal and state waters
- FMP strives for complementary management of spiny dogfish in federal and state waters
- Final Rule and 30-day implementation period expected by end of 2024


No Overnight Soaks (8pm-5am) for Federal Spiny Dogfish Permit Holders

Option 1

Print Counters

Status Quo: All gillnet harvesters of spiny dogfish that do not possess a federal spiny dogfish permit and only harvest in state waters may continue to soak nets overnight in the state waters portion of the bycatch reduction areas.

Option 2



New Jersey No action required.

Maryland and Virginia

Prohibit overnight soaks (8pm-5am) of roundfish gillnets of mesh size between 5.25-10" from November through March for spiny dogfish permit holders within the Bycatch Reduction Areas.

Option 3



New Jersey

Prohibit harvest or possession of spiny dogfish caught using roundfish gillnets of mesh size between 5-10 inches <u>that were</u> left in the water for any portion of the time period between 8:00 p.m. ET each day and 5:00 a.m. ET the following day from May 1 through May 31 and November 1 through November 30 within the New Jersey Atlantic Sturgeon Bycatch Reduction Area.

Maryland and Virginia

<u>Prohibit harvest or possession of</u> <u>spiny dogfish caught using</u> roundfish gillnets of mesh size between 5.25-10" <u>that were left</u> <u>in the water for any portion of</u> <u>the time</u> period between 8:00 p.m. ET each day and 5:00 a.m. ET the following day from November through March within the Delaware and Maryland, and Virginia Bycatch Reduction Areas.



Spiny Dogfish Management Board October 2024

Background

- June 2024: Board approves quota of 11,331,747 pounds
- Finalized catch data indicated a 1,082,487 pound overage of the 2023/2024 ACL, due to higher discards
- September 2024: NOAA Fisheries extends emergency action of 2024/2025 commercial quota, also includes the 2023/2024 overage payback applied to 2024/2025 quota
- New federal commercial quota = 10,249,260 pounds

Rollover Provision

- All states/jurisdictions except NY and NJ requested to utilize rollover provision.
- Rollover Added Quota = 538,467 pounds (600,649 pounds if include NY/NJ)
- Current difference between state and federal quota with rollover = 1,620,954 pounds
- Difference between state and federal quota if adjust = 538,467 pounds

Implications

- If states are projected to harvest over federal quota, then federal waters are closed and current federal permit holders cannot land dogfish.
- Any catch over the federal ACL would be deducted from a future fishing year.

Board Action to Consider

 Consider revising FY 2024/2025 quota to 10,249,260 pounds.

–Requires 2/3 majority
