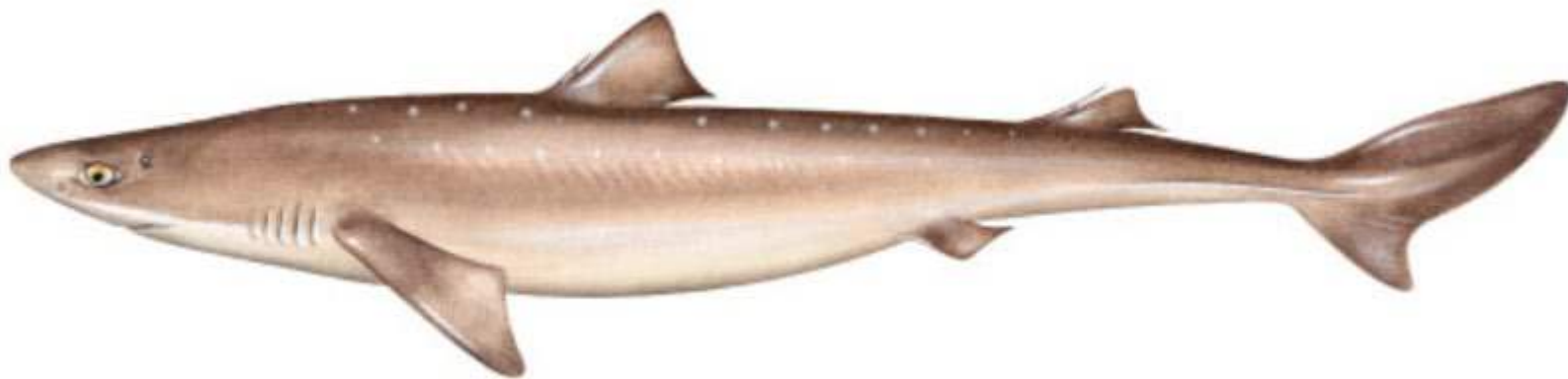

ASMFC Overview



- Comprised of 15 Atlantic coast states
 - ME-NC participate in mgmt. of spiny dogfish
- Atlantic Coastal Fisheries Cooperative Mgmt. Act
 - Regulatory authority in state waters
- Quarterly Board Meetings
 - One state, three commissioners, one vote
- Joint federal management between MAFMC and NEFMC

Draft Addendum VII Timeline



August 2024	Spiny Dogfish Board Tasks Staff to Develop Draft Addendum VII
August – October 2024	Staff Develops Draft Addendum VII for Board Review
October 2024	Spiny Dogfish Board Reviews Draft Addendum VII and Considers Its Approval for Public Comment
November 2024 – January 2025	Board Solicits Public Comment and States Conduct Public Hearings
February 2025	Board Reviews Public Comment, Selects Management Options and Considers Final Approval of Addendum VII
TBD	Provisions of Addendum VII are Implemented

Background



- Proposed rule published by NOAA Fisheries in August 2024
 - Area-based gear requirements include both federal and state waters
- FMP strives for complementary management of spiny dogfish in federal and state waters
- Final Rule published December 18, 2024.
 - Implementation May 1, 2025

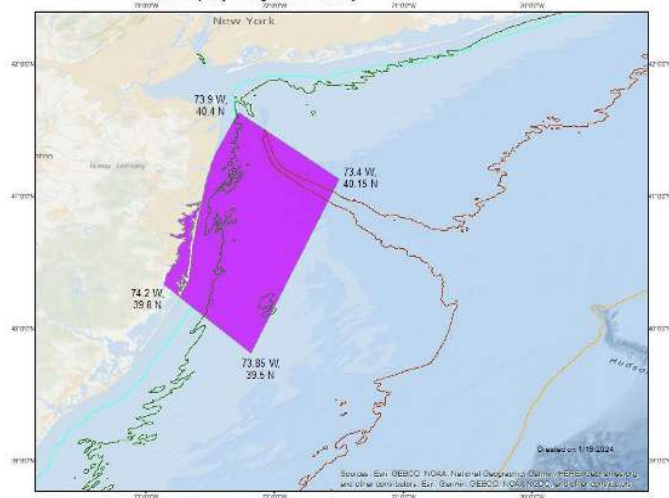

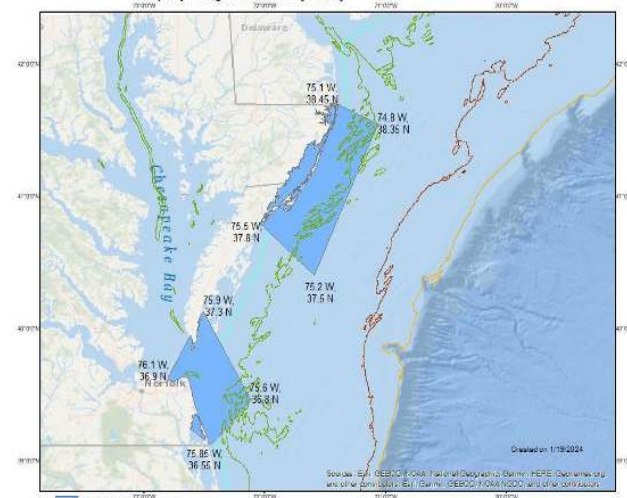
New Jersey Bycatch Hotspot Polygon - Monkfish Fishery

Option 1



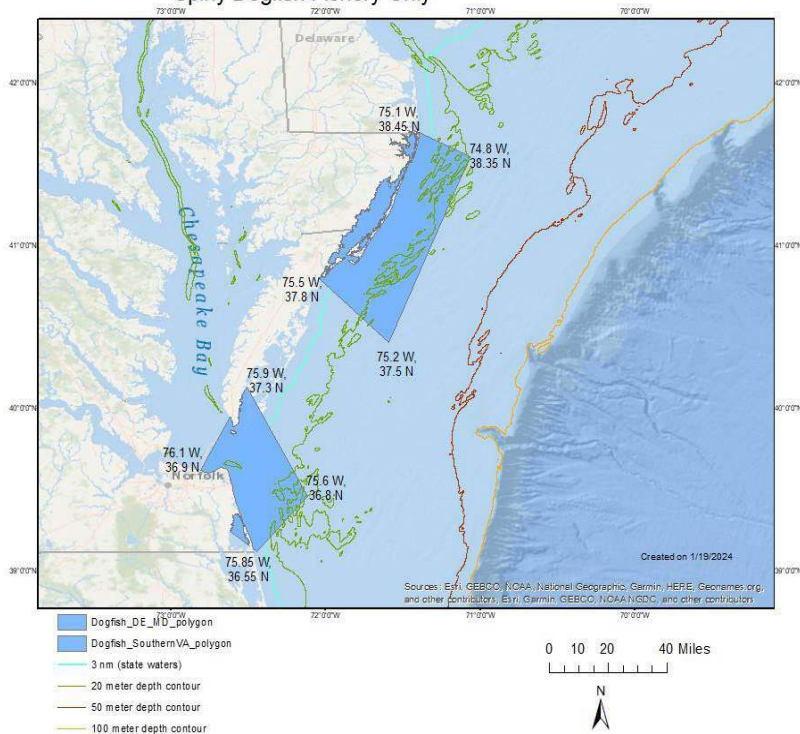
Status Quo: All gillnet harvesters of spiny dogfish that do not possess a federal spiny dogfish permit and only harvest in state waters may continue to soak nets overnight in the state waters portion of the bycatch reduction areas.

Option 2



Delaware/Maryland and Virginia Areas

Delaware, Maryland, Virginia Bycatch Hotspot Polygons -
Spiny Dogfish Fishery Only



November-March

5.25-10" mesh size

Maryland and Virginia

Prohibit overnight soaks (8pm-5am) of roundfish gillnets of mesh size between 5.25-10" from November through March for spiny dogfish permit holders within the Bycatch Reduction Areas.

New Jersey

No action required.

Option 3



New Jersey

Prohibit harvest or possession of spiny dogfish caught using roundfish gillnets of mesh size between 5-10 inches that were left in the water for any portion of the time period between 8:00 p.m. ET each day and 5:00 a.m. ET the following day from May 1 through May 31 and November 1 through November 30 within the New Jersey Atlantic Sturgeon Bycatch Reduction Area.

Maryland and Virginia

Prohibit harvest or possession of spiny dogfish caught using roundfish gillnets of mesh size between 5.25-10" that were left in the water for any portion of the time period between 8:00 p.m. ET each day and 5:00 a.m. ET the following day from November through March within the Delaware and Maryland, and Virginia Bycatch Reduction Areas.

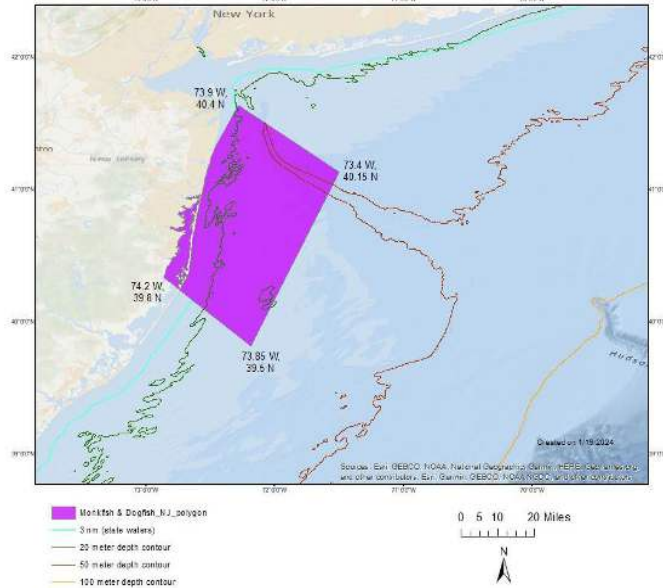

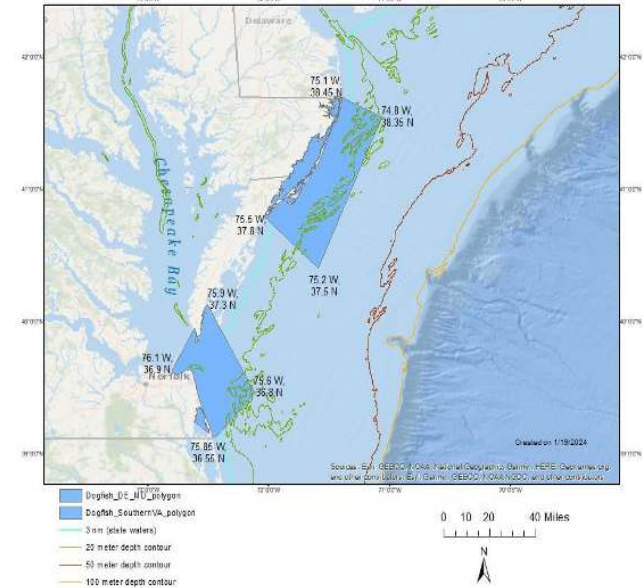
