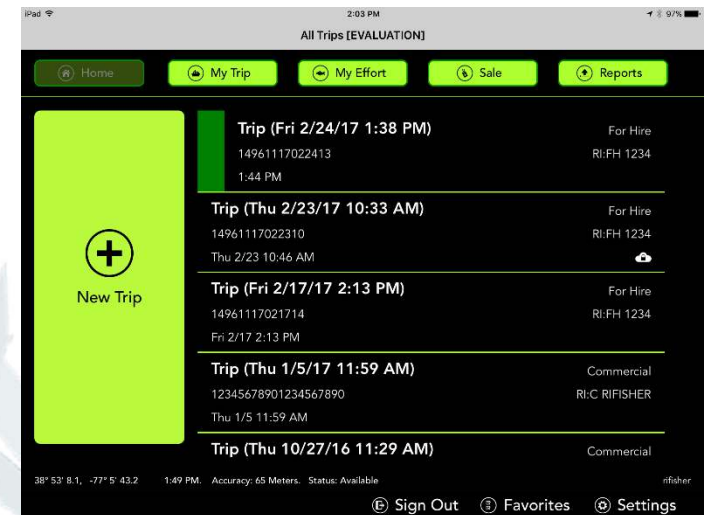

Program Update: Data Warehouse



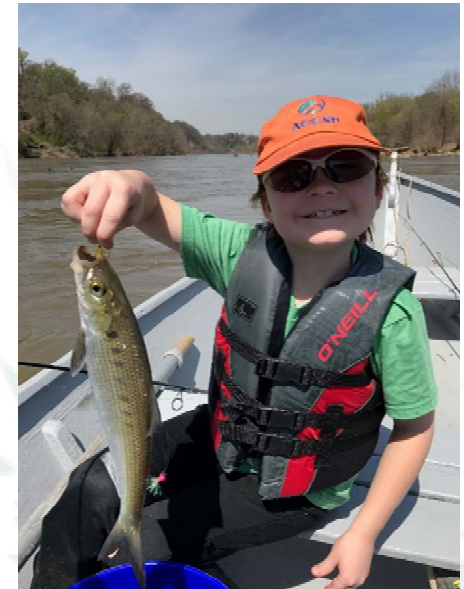
- **Data Warehouse**

 - Preliminary 2016 Data loaded
 - New server purchased and installed
 - Expect to go on-line early June

Program Update: APAIS Update



- Wave 1 data and report delivered
- Wave 2 completed in field; ACCSP processing data now
- Wave 3 data collection just started and on track
- SEAS (Socio-economic) data collection going smoothly
 - Response rate higher than anticipated
- State becoming more familiar with processes
 - Seasonal staff hired and trained
 - Performing survey monitoring and maintenance
 - Site Registry and Vessel Directory updates
 - QC visits and state staff meetings

- **Clarified for-hire sampling procedures**
 - Vessel sampling frame
 - Headboat assignments
- **For-Hire participation in MRIP surveys**

 - Developing ACCSP/MRIP coordinated outreach campaign– including handouts and incentives– to improve response rates
 - Improve vessel directory by States building relationships with captains and expanding vessel directory to distribute sampling.
- **Council logbook initiatives**
 - Included in MRIP implementation plan

Annual meeting held on April 4th:

- **New Data Warehouse went live in Nov 2016!**
 - Compiling list for first round of enhancements
 - Working to further improve display of non-confidential data to the Public
- **Swipe Card program standard**
 - Released swipe programs for MA and ME in Fall 2016
 - ME program expanding to scallop for 2017-2018 season
 - Working with Partners to develop Program Standard
- **SAFIS Redesign, and Integrated Reporting**
 - Tom Hoopes developed requirements for redesign in Fall 2016
 - Database structure and data transfer processes to be documented this summer and begin development in 2018
 - New design to incorporate Integrated Reporting and Universal Trip IDs
 - Integrated Reporting Workshop scheduled for tomorrow

- Update ACCSP Name - **APPROVED**
 - 169554 ANGELFISHES → BUTTERFLYFISHES
 - 553237 ANGELFISH → ANGELFISHES
- Addition of forage species and species groups to SAFIS species table - **APPROVED**

- **Pending Items**

- Seized by Law Enforcement will be a disposition category instead of a single disposition with individual codes to indicate Food, Bait, etc.
- Review of gear attribute standards

RFP Workgroup Recommendations



1. Module Reprioritization Options

- I. Status Quo
- II. All modules equal (Max score of 8) – RFP Workgroup Recommended Option
- III. Modules flipped (Bio/Bycatch 10pts; Catch&Effort, Socioeconomic 8pts)

Operations Recommendation: Table till FY19

- The committee preferred to discuss this further at their in-person meeting in September
- Of the options given, no consensus
- Concerns with equalizing Bycatch and Social & Economic with Catch & Effort and Biological
 - Is an investment in Bycatch going to have a the long-term effect like Catch and Effort?

2. Maintenance Scoring

- I. Score Maintenance projects utilizing full ranking criteria sheet
- II. Score Maintenance projects based on a condensed scoring approach – RFP Workgroup Recommendation
 - A. Maintenance Ranking (0-10)
 - i. Achieved Goals (3pts)
 - ii. Properly Prepared (1 pt)
 - iii. Data Delivery Plan (2 pts)
 - iv. Merit (3 pts)
 - v. Level of Funding (Decreased (1 pt), Maintain (0pt), Increased (-1 pt))
 - B. Condensed scoring approach only to be used if funding available exceeds total Maintenance funding requested; if funding shortage, return to full standard ranking approach

Operations Recommendation: Accept RFP Workgroup Recommendation

- 3. RFP Workgroup recommends consolidating metadata scoring row into the row “Improvement in data quality, quantity and timeliness”. Committee members should include metadata when scoring this row moving forward. Metadata would be replaced by Data Delivery Plan**

Ranking Guide – Maintenance Projects: (to be used only if funding available exceeds total Maintenance funding requested)

Ranking Factors	Point Range	Description of Ranking Consideration
Achieved Goals	0 – 3	Proposal indicates project has consistently met previous set goals. Current proposal provides project goals and if applicable, intermediate metrics to achieve overall achieved goals.
Data Delivery Plan	0 – 2	Ranked based if a data delivery plan to Program is supplied and defined within the proposal.
Level of Funding	-1 – 1	-1 = Increased funding from previous year 0 = Maintained funding from previous year 1 = Decreased funding from previous year
Properly Prepared	-1 – 1	-1 = Not properly prepared 1 = Properly prepared
Merit	0 – 3	Ranked based on subjective worthiness
