**Re:** Federal Legislative Tracking Sheet: 113<sup>th</sup> Congress

The 113<sup>th</sup> United States Congress is underway. Please find attached an overview of federal legislation with major impacts on Atlantic fisheries, as well as more comprehensive tables providing summary information of key federal legislation introduced in the 113<sup>th</sup> Congress. The tables are divided into three categories:

Priority I: legislation with a major impact on Atlantic Coast fisheries

Priority II: legislation relating to ocean and fishery policy with minimal impact on the Atlantic Coast Fisheries disaster legislation: bills directing federal assistance to fisheries with disaster declarations

This is a living document, and it will be updated quarterly or as key bills are introduced, or acted on. The document is not intended to summarize all legislation that might affect oceans and coasts, nor does it list the complete contents of bills. #### **Overview of Federal Fisheries Issues**

2013 is shaping up to be an important year for Atlantic Coast fisheries. Budget cuts will continue to be a focal issue, but many others will take center stage throughout the year. Among those: reauthorizing the expiring Magnuson-Stevens Act, fisheries disasters in New England and the Mid-Atlantic, seafood labeling fraud, and another complicated appropriations process.

## **Magnuson-Stevens Act Reauthorization:**

The current authorization of the Magnuson-Stevens Fishery Conservation and Management Act expires on September 30, 2013, and Congress has already begun the lengthy process of reauthorizing the law. The House Committee on Natural Resources held its first hearing of the year on March 13 and the Senate Committee on Commerce, Science, and Transportation held its first hearing on March 18. These were the first of many this year and were intended to bring stakeholders together to begin the process of identifying the top problems that need to be addressed.

A great deal of time was spent on the whether the reauthorization should include increased flexibility in catch limits and stock rebuilding schedules. This debate was lively in the House, where Massachusetts lawmakers Stephen Lynch (D-MA), John Tierney (D-MA), and Bill Keating (D-MA) pushed for more flexibility while Massachusetts Representative and Senate candidate Ed Markey (D-MA) said he thought the current rules for catch shares should remain in place.

As you know, 2006 provisions added to the Magnuson Act required the National Oceanic and Atmospheric Administration (NOAA) to specify annual catch limits to end overfishing in all federally managed fisheries by 2011. NOAA¢ final rule established catch shares, requiring regulators to set total catch limits for each population or species of fish by allotting a portion of the allowable catch to fishermen. As you well know, these new regulations have put a severe strain on New England and South Atlantic fisheries in particular, and many Members and Senators representing these regions may be looking to add flexibility to the law.

Other items discussed include: basing annual catch limits on better science; requiring participant approval of new catch share programs; allowing rebuilding flexibility for certain fisheries; using NOAA enforcement funds to acquire better fisheries information; expediting decisions on commercial fisheries disaster assistance; replacing NOAA¢s observer program with electronic monitoring; and requiring better transparency for the activities and decisions of the regional fishery management councils.

## **Fiscal Year 2013 Fisheries Funding:**

The latest Continuing Resolution (H.R. 933) was signed into law on March 26, 2013 and contained a full appropriations bill for Commerce, Justice, and Science (CJS) for the remainder of FY2013. This is important (and good) because it gives the Department of Commerce some latitude in implementing automatic cuts required by law, colloquially known as the sequester. Within NOAA's National Marine Fisheries Service (NMFS) appropriations, H.R. 933 provided \$437 million overall for Fisheries and Research Management programs, which is \$17.36 million above 2012 funding levels. The specific funding lines for FY2013 Fisheries Research and Management appropriations are listed below in thousands of dollars.

## Fiscal Year 2014 Appropriations:

On April 10, 2013 the President submitted his FY 2014 Budget Request to Congress. The budget for NOAA contained \$31,124,000 for Regional Fishery Management Councils and the Atlantic States Marine Fishery Commission, a decrease of \$731,000. Also notable was the inclusion of \$2.5 million for Interjurisdictional Fisheries Act (IJFA) Grants, which the President and House had previously targeted for elimination. The IJFA authorization expired on September 30, 2012 as was authorized for \$5 million per year. The President further recommended reauthorizing the program at \$3.09 million per year. Additionally, the Species Recovery Grant Program received a significant increase of \$15 million to \$17.8 million per year. These grants are used by states for the conservation and recovery of marine and anadromous species under NMFS¢s jurisdiction and listed under the Endangered Species Act. Fisheries Statistics and Fisheries Information Network funding for FY 2014 both received a slight bump as well, with increases of \$206,000 and \$20,000, respectively.

In Congress, the House passed its FY 2014 budget on March 21, 2013 and the Senate passed its FY 2014 budget on March 23, 2013. The two budgets differ greatly, but serve mainly as a roadmap and do not go into detail on individual programs of funding lines. However, the House and Senate Appropriations Committees are beginning work on appropriations bills and we should see the first drafts within the next month. On April 11, 2013 Acting Secretary of Commerce, Rebecca Blank testified before the House and Senate Commerce, Justice, Science Appropriations Subcommittees about the President® Budget Request. She fielded questions on a wide range of fisheries issues including electronic monitoring implementation, catch shares, and fisheries disasters.

## **2012 Fishery Disaster Declarations:**

In late 2012, the Department of Commerce assigned disaster designations for fisheries in a number of New England states due to an anticipated reduction in catch limits as well as damage sustained during Superstorm Sandy. The affected states include Maine, New Hampshire, Massachusetts, Rhode Island, Connecticut, New York, and New Jersey. The designation paves the way for federal assistance funds to repair or restore fishing equipment and infrastructure, compensate for losses, restore fisheries habitat, support workforce education, provide low-interest loans, and conduct monitoring and cooperative research focused on improving stock assessments.

While a disaster designation allows fishermen in the affected regions to qualify for the federal assistance, Congress must still appropriate the funds. Congress attempted to attach \$150 million in disaster assistance funding to the Superstorm Sandy Relief Bill, but were ultimately resulted in only \$5 million for fishermen in New York and New Jersey affected by Superstorm Sandy. Efforts to secure additional federal aid are ongoing and moving forward in both the House and Senate. A list of those efforts is included in the table below.
