


# 2013 Coastal Sharks FMP Review and State Compliance




## Commercial Landings by

## **Monitoring**

- There are no specific surveys aimed at coastal sharks, however, 5 surveys encountered sharks in 2012
- Of these surveys, there were trends in two of them (DE and SC)
  - > Sand tiger catch per mile remained high
  - ➤ Sandbar and smooth dogfish catches continued to increase
  - ➤ Highest recorded CPUE of LCS in SC gillnet survey since 1998



## **State Compliance**

- PRT reviewed all state compliance reports
- All states that submitted reports had regulations consistent with the FMP
  - >CT has not submitted reports
    - Last year, CT had not implemented the appropriate recreational measures (currently in the middle of it)





## Implementation Plans for Addendum III to the Coastal Sharks

### **Overview**

- Addendum III was approved in October 2013, and will be implemented March 1, 2014
- States submitted implementation plans by January 6, 2014 to meet the requirements of Addendum III
- PRT reviewed implementation plans and has the following recommendations



## **Elements of Compliance**

- 1) Follow NOAA Fisheries openings and closures for the following groups: Aggregated Large Coastal, Hammerhead, Blacknose, Non-Blacknose Small Coastal, Pelagic.
- 2) Enforce a minimum recreational size limit of 78 inches for all hammerhead shark species (smooth hammerhead, scalloped hammerhead and great hammerhead)



### **Quotas and Possession Limits**

All states have the ability to follow NOAA
 Fisheries' openings and closures by March 1,
 2014





### **Recreational Size Limit**

- Most state plans allow for enforcement of minimum size limit by March 1, 2014
  - RI will not have language in place until May 1
    - This did not concern the PRT because RI does not encounter coastal sharks prior to that date





## Maine and New Hampshire's de minimis requests

- ME and NH requested de minimis for Addendum III
- Sharks addressed in Addendum III do not occur in these state's waters
- PRT and TC recommend granting de minimis





### **General Recommendations**

- Approve implementation plans for all states and confirm compliance during the next FMP Review
- Approve Maine's and New Hampshire's de minimis requests





## **Sharks Season and Possession Limits**

## Background

- Board directed PDT to develop a white paper on season and possession limit options in response to repeated conversations at Board meetings
  - PDT held a conference call and made following recommendations
- Board follows NOAA Fisheries but this is subject to change under adaptive management



### **Seasons - Problem**

Board has discussed and had issue with NOAA
 Fisheries' season at multiple Board meetings

 Setting a specific date could help to streamline this process and eliminate repeat conversations





## Possible Issues with Various Opening Dates

- FL fishermen have expressed concern with January 1 – targeting other species at that time
- Time/area closures for bottom longline fishermen in federal waters off NC (1/1 – 7/31)
- VA, MD, DE and NJ state waters are closed
   5/15-7/15



### **PDT Discussions**

- Different seasons for state and federal waters would be difficult to manage, monitor and enforce
  - Some states allow federal permit holders to land sharks during state closed seasons (enforcement issues)
- PDT recommends writing a letter outlining a set date
  - Letter could be written every year, or serve for multiple years



## **Optimal Date?**

- PDT investigated landings for each species group since 2008 (due to recent changes in management) to determine what "always open after" date would be effective
  - LCS is the only species group that has posed problems
  - Other species groups could continue to follow NOAA Fisheries



### **Large Coastal Sharks**

- Average season length for 2008-2012 is 151 days, with three years (2008, 2011 and 2012) reaching 80% of the quota.
  - NOAA fisheries closes a fishery when 80% of the quota is projected to be reached.
- In order to prevent an early closure, this would require an opening date of August 2 at the latest.

### **PDT Recommendations - Seasons**

- June or July 1 "always open after" date would impact FL
  - PDT agreed on a recommendation of March 1 to minimize impact on FL
- Discussion with FL TC representatives confirmed that this "always open after" date would not significantly affect FL's fishery
  - Sharks still are found in FL waters, so are still available to FL fishermen



#### **PDT Recommendations - Seasons**

 The PDT recommends that the Board send a letter to NOAA Fisheries each year, or write one letter for multiple years, requesting a March 1 as the "always open after" date





### **Adjustable Possession Limits**

- NOAA Fisheries has the ability to change possession limit in-season
  - This flexibility has not been used
- Board discussed this in 2011 and determined that most states have the flexibility to address this without an addendum
  - It is unclear how quickly states could respond
