## **MEMORANDUM**

**SUBJECT:** Revised Preliminary 2025 Atlantic Menhaden Quota Allocations, Accounting for Redistributed Relinquished Quota

This memo revises 2025 Atlantic menhaden quotas previously detailed in Memo 24-98 based on the redistribution of relinquished quota (Table 1).

Provisions of Amendment 3 allow for jurisdictions to relinquish all or part of the jurisdiction's Atlantic menhaden quota. For 2025, Delaware relinquished 1,000,000 pounds (454 metric tons). Relinquished quota is redistributed to the other jurisdictions (i.e., those which did not relinquish quota) based on average landings from 2018, 2019, and 2021.

The revised quotas account for the 1% episodic events set aside (EESA) program but do not account for potential overages from the 2024 fishing year. The TAC is 231,214.50 mt after accounting for the EESA.
