**Per Diem:** Room Rate: \$150 plus \$25 daily urban destination fee and tax (sgl/dbl); Meals: \$98 (\$26/\$29/\$43)

**Mileage Rate:** \$0.725/mile, eff. January 1, 2026. Rental cars must be specifically authorized.

**Airport Transportation:** The Viking Hotel is just over 28 miles from the Rhode Island T.F. Green International Airport (PVD) in Providence, RI. The hotel does not offer a shuttle.

**Local Transportation:** The hotel is in the heart of Newport, RI and is within walking distance of many local restaurants and eateries.

**Basic Guidelines:** Travelers must select the most reasonable and cost-effective airfare and are responsible for determining their arrival and departure times. Commissioners (or designated proxies) may attend all meetings; all other travelers are eligible for reimbursement only for board or committee meetings of which they are a member. If the distance from your office to the meeting site is less than 35 miles, ASMFC will not reimburse hotel, mileage, or per diem; however, unusual expenses such as parking or tolls may be reimbursed. ASMFC reserves the right to disallow travel expenses deemed excessive or unnecessary for the conduct of Commission business. A Cost Comparison Form is required when requesting approval for alternate transportation, lodging, or travel routes.

**Parking:** Discounted valet parking at the hotel is \$25 per vehicle per night.

**Reimbursement:** You must submit an ASMFC travel voucher with receipts within 30 days of the final day of travel. Electronic travel vouchers and scanned receipts are preferred and should be sent to [accounting@asmfc.org](mailto:accounting@asmfc.org). Vouchers and receipts will also be accepted via snail mail if emailing is not an option.
